MODULE DESCRIPTION

This module provides students with the foundations to understand the key concepts and tools used in Finance. It offers a broad overview of the financial environment under which firms operate and equips students with the conceptual and analytical skills necessary to make sound financial decisions for the firm. Throughout the course, specific examples will be considered as will some of the basic ethical issues involved in various financial decision-making contexts.

The module employs pre-recorded videos (posted ahead of the scheduled lecture in which the materials will be discussed), virtual lectures (conducted live using a video conferencing software), and small group tutorials to convey the material. Each student is expected to contribute regularly to discussions in their assigned lecture and tutorial sessions.

The material for this module needs to be absorbed consistently. Students are expected to attend the lectures and tutorial sessions prepared to discuss the materials. Therefore, students are expected to view the prerecorded videos **before** we cover the material in the lectures and tutorial sessions. Students should also find it helpful to read the assigned readings **before** their corresponding lecture and tutorial sessions.

LEARNING OUTCOMES

The objective of this course is to provide the foundations needed to understand important key concepts and tools used in finance. By the end of the semesters, students enrolled in this module should gain basic understanding of the following topics: financial management, time value of money, risk and return, capital budgeting, and financial planning. Students will also be introduced to bonds, common stock, and options.

PREREQUISITE

ACC1002/ACC1002X Financial Accounting. In addition, it is preferred that students have taken the equivalent of BZ1008 Statistics.

2. Financial calculator
