#### **Course Objective:**

The objective of this module is to introduce students to the consumer banking wealth management industry. Students will be introduced to the wealth management industry in terms of understanding the global political environment, Singapore's regulatory framework, and how the industry works. They will learn how to help clients to understand their financial health and make good informed investment decisions to meet their financial objectives.

Wealth management is an integral part of the financial industry. Singapore has a strong reputation as a wealth management center and is looking to further develop and strengthen its position. The importance of working with industry players to develop courses on wealth management cannot be overstated. DBS is one of the biggest player in this area. Hence, this module is in collaboration with DBS trainers. The trainers from DBS will be the main instructors for the module, while the NUS professor facilitates the classes.

#### **Class Arrangement:**

Classes by the DBS trainers will be conducted via the DBS Webex platform. Students **HAVE TO ENSURE** that the devices they used have functioning video (webcam) capabilities and the video (webcam) be turned on at all time.

Classes by the NUS professor will be conducted in a normal face-to-face (F2F) classroom setting. Students who are not able to join the F2F classes due to "Stay Home Notice", being in quarantine, and the likes, will join the class via Zoom instead. Likewise, students **HAVE TO ENSURE** that their video (webcam) be **turned on at all time**.

Class participation:

Although the classes will be conducted mostly online, students are expected to participate actively during classes. There will be class activities during the class sessions and students will be graded during these activities.

#### Individual Assignment:

Each student will choose a wealth management product and a target clientele and video record a 10 minutes sale pitch. The video recording is due on **October 31**.

This term test will be a 60-minute test. Students are to make sure that they are available to sit for the test.
