Class Arrangement:

Class Participation:

Students are expected to participate actively during classes. Marks will be awarded not based on quantity but how much one contributes to the learning of the class.

<u>Term Test I:</u>

This term test will be a 90-minute test to be held during class time. Students are to make sure that they are available to sit for the test.

Term Project:

This a group project. The objective of the project is to allow students to research into issues and questions related to the topics covered in the module and to share the knowledge they have acquired with the rest of the class. The project consists of a written report (due on March 12, 6 pm) and a presentation.

Term Test II:

This term test will be a 75-minute test to be held during class time. Students are to make sure that they are available to sit for the test.

Important Points to Note:

- 1. *Financial calculators may be* needed in the course.
- Attendance: Students must not miss more than 2 F2F classes (not including absence due to medical (accompanied by medical certificates), compassionate, or other valid reasons. Violators will be heavily penalized.
