Overview

This module deals with the legal issues that affect real estate development. It examines the regulatory framework for real estate development, including taxation. Topics covered include how rights and interests in land concern real estate developers, acquisition of land for public and private development, the regulatory framework for land use planning and zoning, development control, statutory regulation of developers, liability of developers in contract and in tort, the concept of betterment value and the land betterment charge which has replaced development charge and differential premium.

Learning Outcomes

Students will be able to:

- Understand the implications of rights and interests in land from the perspective of real estate development.
- Appreciate the legal framework for land acquisition for public development in Singapore and the compensation provisions.
- Realise the role played by the legal framework for planning and control over development of land in Singapore.
- Understand the ways in which land can be acquired for private development, and the process of transfer of title to the developer.
- Understand the implications of the Land Titles (Strata) Act in relation to collective sales.
- Understand how developers are strictly regulated for uncompleted properties.
- Understand the various types of taxes involved in the development of real estate.
- Understand the liability of developers for building defects in both contract and tort.
- Identify the legal issue/s in disputes without being distracted by irrelevant/immaterial information.
- Apply legal principles correctly to case-studies.
- Use legal reasoning to support the stance taken by different parties in legal disputes.
- Make better use of the English language through the appropriate choice of words, and articulate more
 effectively.
