Course Objective:

The objective of this module is to introduce students to the consumer banking wealth management industry. Important issues, trends, and challenges of the industry will be explored. Technical knowledge of some of the financial instruments clients typically invest in and the financial planning and sales process will be covered. Soft skills in developing clients trust and loyalty will also be taught.

Class participation:

Classes will be conducted in a participative manner. Students are to be prepared for classes, including and especially reading the cases, and participating actively in class discussions.

Term Project:

This a group project. The objective of the project is to allow students to research into issues and questions related to wealth management and to share the knowledge they have acquired with the rest of the class. The project consists of a written report (due on March 8, 6 pm) and a presentation.

Quiz I and II:

These are short quizzes to be held during class time. Students are to make sure that they are available to sit for the quizzes.

Group Case Presentation

Each group will be assigned to work on and present one case study which will be discussed in class.

Group Case Report

Each group will be assigned to work on and write a report on one case study (other than the case study they presented) which will be discussed in class.

Points to Note:
