Course Description:

ACC2707 focuses on understanding how firms' operating, financing, and investing activities are recorded and disclosed in the financial statements, with an emphasis on assets and their related accounts. In Singapore, public firms prepare financial reports following Singapore Financial Reporting Standards (SFRS) which are based on International Financial Reporting Standards (IFRS). Due to its relevance in Singapore and wide adoption in many other important economic regions, our topics in this course will be mainly developed around IFRS. Throughout this course, students develop the skills required to prepare and analyze corporate financial statements, as well as an understanding of how managerial incentives interplay with financial reporting.

Course Prerequisites:

ACC1701 Accounting for Decision Makers or equivalent introductory financial accounting course. Approval from the BBA office is required for students with non-accounting majors and exchange students.
