Overview

This course is intended to equip students who will be future business managers with legal knowledge that is relevant to commercial transactions so that they can, not only understand the rights and obligations of a business, but also take appropriate actions, both before and after the problem arises – so as to reduce possible negative impact on the business or to advance the interests of the business. The course will also discuss the interaction between law and ethics, and further some international (particularly Asian) comparisons will also be highlighted to prepare students for a world which is highly globalised.

Course Objectives

Being able to:

- (1) predict the legal outcomes for common problems that may arise in a typical business setting,
- (2) take appropriate measures (both law and non-law related) to deal with such problems before/after they arise and
- (3) articulate views relating to the subject at least in a class setting.
